Update from ISC Executive Manager

- 2021 Meeting DRAFT Minutes
- 2021-22 Section 119 Grant
  - o Covers face-to-face meeting in Anchorage
  - o Still exploring expanded scope of meeting (e.g., workshops/round-tables at ASLC)
  - o Also exploring expanded "youth" involvement
- 2021-22 Annual Meeting
  - o Late January 2022
    - close to AMSS
    - may be virtual
  - o Expand next-gen ISC participants (meeting travel, cover costs to AMSS)
    - if not virtual, then provide travel for 5 ISC next-gen participants (1 from each region)
    - next-gen = potential recruits for next generation of ISC reps and participation
  - o Expand the scope of our annual meeting (e.g., travel to ASLC in Seward)
    - Workshop of various topics (science, sampling, tagging, necropsy)
    - Round-table outreach with the public (IK told to the public)
    - Tour facilities, see animals, drone practice(?)
    - Tagging training (train the trainers)
- Suggest making meeting #2 "optional" or "as needed" (vote on this at next face-to-face meeting?)

#### FY22 grant proposal:

- Face to face meeting in Anchorage (adjacent to AMSS) ← looking like this will be virtual
- Travel for 5 "youth" (one from each community)

Try for a day trip (unanimous consent)
Youth involvement (travel, AMSS ← will likely be virtual)

a. Would the ISC like to proactively work toward facilitating the concurrent use of Indigenous-Knowledge and Scientific-Knowledge for co-management? Examples may include supporting research, requesting research, and/or direct participation.

- b. Does ISC want to request information and/or research into the rate in which various sedatives and other drugs are metabolized by ice seals that have been handled?
- c. Does the ISC want to explore the potential use of an app to conduct harvest monitoring and other ice seal documentation as needed by the ISC<sup>1</sup>.

Eg., Indigenous Sentinels Network (ISN), SMART, SIKU, etc.
