A. November 2022: NMFS published the FINAL Programmatic EIS
1) Chapter 7 :

In response to concerns raised by a co-management partner, which included potential risk to wild marine mammal populations and subsistence use of marine mammals, NMFS currently does not authorize the release of rehabilitated ringed, bearded, ribbon, and spotted seals that were rehabilitated beyond the geographical areas where they were stranded in the Arctic. Certain situations, however, would be considered on a case-by-case basis (i.e., an ice seal out of its range; ice seals that are part of an UME, spotted seals in Bristol Bay), and NMFS may reevaluate this decision at any time.
