Report to Ice Seal Committee 2021

Even with the challenges we faced due to Covid-19 over the 2020 season, it was still a busy year. The ASLC marine animal stranding hotline (1-888-774-7325) fielded almost 400 calls, more than we had in 2019, and responded to 65 cases. Of those calls, 5 were ice seals.

When we get phone calls from the general public we work to communicate with local experts or authorities as part of determining an appropriate action which we coordinate with NOAA for approval before proceeding. One case was a pup found in March frozen to the ground near a snow machine trail in Kotzebue. It was cared for by a local biologist for a few days as it awaited air transport. It died the first night after being admitted to ASLC. Necropsy showed it had frostbite and sepsis. Three were young animals who returned to the water: a ringed seal in Nome and two spotted seals. An odd case we received came over a month after the actual observation, we were forwarded a short video of a bearded seal swimming near the docks in Anchorage. In all cases, we also work closely with researchers in order to further scientific understanding of the species.

Thank you to the members of the public, the stranding agreement holders, and invested parties who call our hotline.
